ARTICLE I. IN GENERAL.

6-1. <u>Election of Councilmen.</u>

There shall be elected, as provided by law, two councilmen from each of the three wards. (Ord. No. 619, 6, 5-26-70; Ord. No. 823, 6-7-76.)

6-2. <u>Compliance of State Election Laws.</u>

Except as otherwise provided in this Code or other city ordinances, all elections within the city shall be in compliance with Wyoming Statutes, 1977, Title 22, the "Elections" as may be amended, as the same shall apply to the city. A copy of such laws and of any subsequent laws and amendments thereto shall be kept on file in the office of the city clerk, and the same are made a part of this section by reference, as though incorporated herein at length. ARTICLE II. WARDS.

6-3. <u>Number of Wards.</u>

The city shall hereby be divided into three wards to be known as Ward One, Ward Two, and Ward Three, the boundaries of which shall be as herein set forth, each of the wards having not less then one thousand inhabitants. (Ord. No. 619, 2, 5-26-70; Ord. No. 824, 6-7-76.)

6-4 <u>Ward One.</u>

Ward One shall consist of all the area within the corporate limits of the city of Gillette, lying north and west of the following described boundary line:

Commencing at the intersection of the City of Gillette corporate boundary and the north right-of-way line of Wyoming Highway 14-16;

Thence north westerly along the north right-of-way line of Wyoming Highway 14-16 to the intersection of the eastern boundary of the *Martens Addition* and the northern right-of-way line of Wyoming Highway 14-16.

Thence, southerly along the eastern boundary of the *Martens Addition* to the northern right-of-way line of Wyoming Highway 14-16.

Thence, westerly along the northern right-of-way line of Wyoming Highway 14-16 to the intersection of the northern right-way line and the eastern right-of-way line of South Gillette Avenue.

Thence, southerly along the eastern right-of-way line of South Gillette Avenue to the intersection of the eastern right-of-way line of South Gillette Avenue and the centerline of West 6th Street.

Thence, westerly along the centerline of West 6th Street to the intersection of West 6th Street and the centerline of South Burma Avenue.

Thence south westerly along the centerline of South Burma Avenue to the intersection of the centerline of South Burma Avenue and the southern right-of-way line of Westover Road.

Thence, northwesterly along the southern right-of-way line of Westover Road to the intersection of the southern right-of-way line of Westover Road and the Eastern right of way line of Wyoming Highway 50 (Skyline Drive).

Thence, southwesterly along the eastern right-of-way line of Wyoming Highway 50 (Skyline Drive) to the southern boundary line of Township 50 North, Range 72 West of the 6th P.M.

Thence westerly along the southern boundary line of Township 50 North, Range 72 West of the 6th P.M. to the south-west corner of Township 50 North, Range 72 West of the 6th P.M., as described in "Exhibit A" – Voting Ward Boundaries Map, as amended, which is attached and made part of this Ordinance. 6-5. <u>Ward Two.</u>

Ward Two shall consist of all areas within the corporate limits of the City of Gillette, which are south and east of the following described line: Commencing at the intersection of the City of Gillette corporate boundary and the north right-of-way line of Wyoming Highway 14-16; thence north westerly along the north right-of-way line of Wyoming Highway 14-16 to the intersection of the eastern boundary of the *Martens Addition* and the northern right-of-way line of Wyoming Highway 14-16.

Thence, southerly along the eastern boundary of the *Martens Addition* to the northern right-of-way line of Wyoming Highway 14-16.

Thence, westerly along the northern right-of-way line of Wyoming Highway 14-16 to the intersection of the northern right-way line and the eastern right-of-way line of South Gillette Avenue.

Thence, southerly along the eastern right-of-way line of South Gillette Avenue to the intersection of the eastern right-of-way line of South Gillette Avenue and the southern right-of-way line of West 7th Street.

Thence, westerly along the south right-of-way of West 7th Street to the east intersection of South Gillette Avenue and West 7th Street;

Thence, southerly along the east right-of-way of South Gillette Avenue to the intersection of South Gillette Avenue and the southern rightof-way line of West 10th Street;

Thence, westerly along the south right-of-way of West 10th Street to the intersection of West 10th Street and the easterly right-of-way line of 4-J Road;

Thence, southerly along the east right-of-way line of 4-J Road to the intersection with the south Interstate 90 right-of-way;

Thence, easterly along the southern right-of-way line of Interstate 90 to the intersection with the western right-of-way line of Butler Spaeth Road;

Thence, southerly along the western right-of-way line of Butler Spaeth Road to the intersection of the northern boundary of Dalbey Park;

Thence, westerly along the northern boundary of Dalbey Park to a point intersecting the western right-of-way line of Wyoming Highway 59; Thence, southerly along the Wyoming Highway 59 right-of-way to the intersection of said right-of-way and the southern boundary of the *Annexation Plat Stewart Business Park* as recorded in Book 6 of Plats, Page 159, of the records of the Campbell County Clerk;

Thence, westerly along the southern boundary of said Annexation Plat Stewart Business Park to a point intersecting the southeast corner of the *4-J Addition Annexation* as filed by Ordinance in Book 308 of Photos, Pages 37-38 of the records of the Campbell County Clerk;

Thence, continuing westerly along a portion of the southern boundary and to the south west corner of said *4-J Addition Annexation*;

Thence, northerly along a western boundary of the said 4-J Addition Annexation to a point intersecting the southern boundary of the Stocktrail Subdivision as filed in Book 1 of Plats, Page 102 of the records of the Campbell County Clerk;

Thence, westerly along the southern boundary of said *Stocktrail Subdivision* to a point intersecting the westerly right-of-way line of 4-J Road;

Thence, southerly along the western right-of-way line of 4-J Road, crossing the intersection of West 4-J Road and continuing southerly along the western right-of-way line of Enzi Drive to a point intersecting the southern right-of-way line of Southern Drive.

Thence, southerly along the eastern boundary of the *Annexation Plat South Park Addition* as filed in Book 4 of Plats, Page 70 of the records of the Campbell County Clerk, to the southeast corner of said *Annexation Plat South Park Addition*, as described in "Exhibit A" – Voting Ward Boundaries Map, as amended, which is attached and made part of this Ordinance.

6-6. <u>Ward Three</u>.

Ward Three shall consist of all areas within the corporate limits of the City of Gillette, which are south and east of the following described line:

Commencing at the south-west corner of Township 50 North, Range 72 West of the 6th P.M.;

Thence easterly along the southern boundary line of Township 50 North, Range 72 West of the 6th P.M. to the eastern right-of-way line of Wyoming Highway 50 (Skyline Drive); Thence, northeasterly along the eastern right-of-way line of Wyoming Highway 50 (Skyline Drive) to the intersection of the southern right-of-way line of Westover Road and the Eastern right of way line of Wyoming Highway 50 (Skyline Drive);

Thence, southeasterly along the southern right-of-way line of Westover Road to the intersection of the centerline of South Burma Avenue and the southern right-of-way line of Westover Road;

Thence northeasterly along the centerline of South Burma Avenue to the intersection of West 6th Street and the centerline of South Burma Avenue;

Thence, easterly along the centerline of West 6th Street to the intersection of West 6th Street and the eastern right-of-way line of South Gillette Avenue;

Also, all of the area west of the following described line:

Thence, southerly along the eastern right-of-way line of South Gillette Avenue to the intersection of the eastern right-of-way line of South Gillette Avenue and the southern right-of-way line of West 7th Street.

Thence, westerly along the south right-of-way of West 7th Street to the east intersection of South Gillette Avenue and West 7th Street;

Thence, southerly along the east right-of-way of South Gillette Avenue to the intersection of South Gillette Avenue and the southern rightof-way line of West 10th Street;

Thence, westerly along the south right-of-way of West 10th Street to the intersection of West 10th Street and the easterly right-of-way line of 4-J Road;

Thence, southerly along the east right-of-way line of 4-J Road to the intersection with the south Interstate 90 right-of-way;

Thence, easterly along the southern right-of-way line of Interstate 90 to the intersection with the western right-of-way line of Butler Spaeth Road;

Thence, southerly along the western right-of-way line of Butler Spaeth Road to the intersection of the northern boundary of Dalbey Park;

Thence, westerly along the northern boundary of Dalbey Park to a point intersecting the western right-of-way line of Wyoming Highway 59;

Thence, southerly along the Wyoming Highway 59 right-of-way to the intersection of said right-of-way and the southern boundary of the Annexation Plat Stewart Business Park as recorded in Book 6 of Plats, Page 159, of the records of the Campbell County Clerk;

Thence, westerly along the southern boundary of said Annexation Plat Stewart Business Park to a point intersecting the southeast corner of the *4-J Addition Annexation* as filed by Ordinance in Book 308 of Photos, Pages 37-38 of the records of the Campbell County Clerk;

Thence, continuing westerly along a portion of the southern boundary and to the south west corner of said *4-J Addition Annexation*;

Thence, northerly along a western boundary of the said 4-J Addition Annexation to a point intersecting the southern boundary of the Stocktrail Subdivision as filed in Book 1 of Plats, Page 102 of the records of the Campbell County Clerk;

Thence, westerly along the southern boundary of said *Stocktrail Subdivision* to a point intersecting the westerly right-of-way line of 4-J Road;

Thence, southerly along the western right-of-way line of 4-J Road, crossing the intersection of West 4-J Road and continuing southerly along the western right-of-way line of Enzi Drive to a point intersecting the southern right-of-way line of Southern Drive.

Thence, southerly along the eastern boundary of the *Annexation Plat South Park Addition* as filed in Book 4 of Plats, Page 70 of the records of the Campbell County Clerk, to the southeast corner of said *Annexation Plat South Park Addition*, as described in "Exhibit A" – Voting Ward Boundaries Map, as amended, which is attached and made part of this Ordinance. 6-7. <u>Voting Precincts.</u>

The voting precincts in each ward for any election shall be as now or hereafter established by the board of county commissioners. (Ord. No. 619, 8,5-36-70; Ord. No. 824, 6-7-76.)
