City Proposes 3-Year Utility Rate Plan

City of Gillette staff have proposed a 3-year utility rate plan to be able to maintain infrastructure and level of service given the rising cost of labor, equipment and materials.

The City conducted extensive research and analysis to determine the appropriate future utility rates needed to support ongoing infrastructure improvements and ensure reliable services for our customers. Last fall, the City retained FCS Group, Inc. to perform a utility revenue requirements study. FCS presented their findings and recommendations to City Council during the February 14 regular meeting. Ultimately, the report recommended a series of rate increases over the next three years combined with a transfer of \$4.8M from the City General Fund.

While actual impacts to individual customers will vary based on the type of customer and their usage levels, increases for the typical residential user have been estimated as follows:

- As of May 1, 2023, a 6.9% increase, or approximately an additional \$14.13/month
- As of May 1, 2024, a 6.2% increase, or approximately an additional \$13.61/month
- · As of May 1, 2025, a 4.2% increase, or approximately an additional \$9.91/month

The proposed rates were approved on first reading by City Council during the March 14 meeting. The ordinance must be approved on three readings; it will be considered again by Council on April 4 and April 18. If approved, the new rates will take effect on May 1, 2023.

Snow was expected for Wednesday, March 8, 2023, in the evening and Night crew was placed on call for the predicted snow.

Wednesday 3/08/2023

Night Crew was called in at 7:00 p.m. Winds were strong at 25 mph and the temperature was around 27degrees. Nights operated for 12 hours. Strong winds caused drifting and temperatures dropped to a low of 18 by early morning. Night crew concentrated on East, Central, West, Downtown, and Trouble priorities. Approximately 2-4 inches of snow fell during this Wednesday night.

Thursday 3/9/2023

Day crew took over operations at 7:00 a.m. and continued plowing priorities. Winds were calm for the entire morning and no additional snowfall occurred. With improved weather conditions and plowing operations the roadways were cleared and safe for travel.

With the storm clearing, and safe road conditions, Event 13 was closed at 11:30 a.m.



The storm and wind were not as strong as forecasted. No snow is forecasted for the following week.


