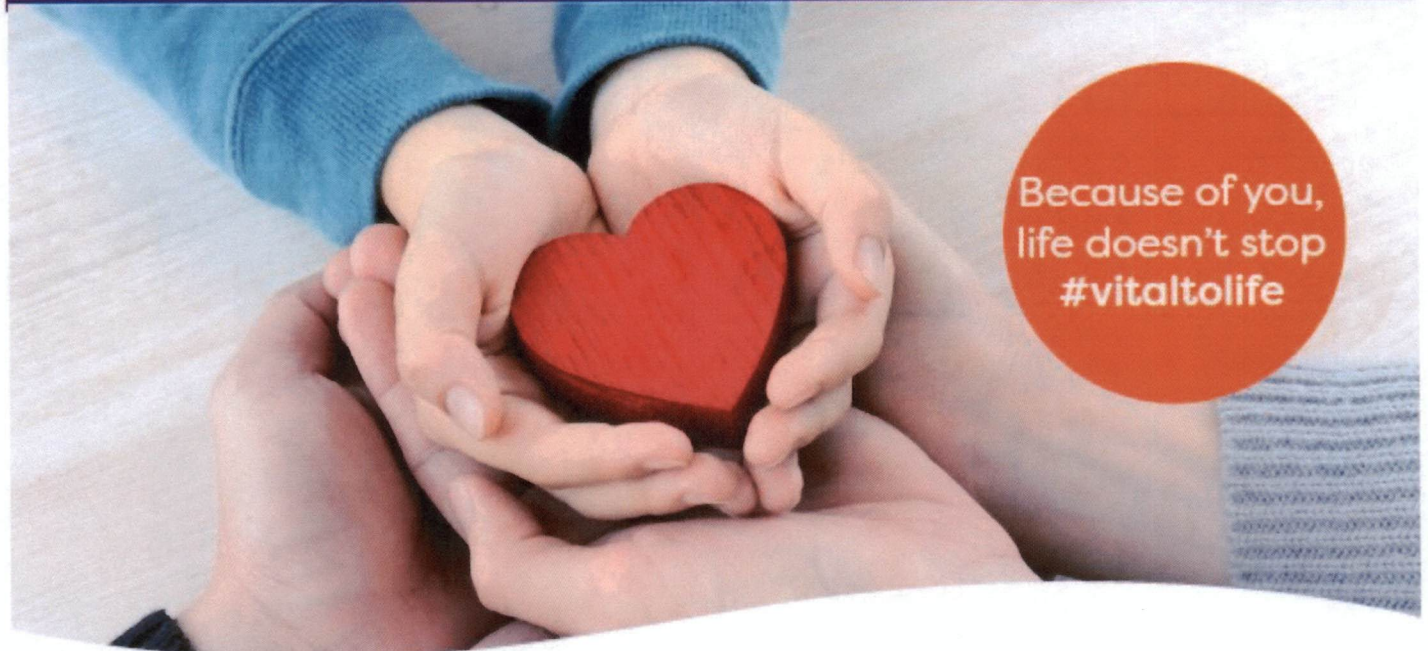
Some helpful Splash Park tips and rules:
