Softball Commission

Five (5) Positions

This commission was established in 2023 to review and adjudicate appeals based on the City's Field Use Policy. The commission shall be made up of five individuals who have a vested interest in youth sports in Campbell County and shall be appointed by the governing body of the City. For the purpose of evaluating applications, a "vested interest in youth sports" means an individual who currently serves or who has served as a coach, on a board of directors, or similar volunteer role(s) for a youth sports organization in Campbell County. Preference will be given to individuals who volunteer their time to youth sports. The City Public Works Director and staff shall provide administrative and clerical support for the commission. Initial appointments will be two (2) 3-year terms, two (2) 2-year terms and one (1) 1-year term; after initial terms expire all additional terms shall be 3-year terms. This commission will meet on an as-needed basis.
