Storm Event Overview:

On the evening of Tuesday, February 26th, the forecast predicted snow and strong winds. Precipitation started as rain and snow at 8:00 p.m., transitioning to all snow by 8:30 p.m. as the temperature dropped to 29 degrees and winds reached 25 mph. The blowing snow led to rapidly deteriorating road conditions. Upon receiving reports of slick roads, the Gillette Police Department notified Streets, prompting the Night crew to be called in to address the situation. Event 7 was declared at 9:00 p.m.

Monday 02/26/2024

At the start of the event, the temperature was 27 degrees with winds gusting to 36 mph. The Night crew worked 10 hours, clearing drifts, curbing snow, laying material, and focusing on the priority routes - East, Central, West, Downtown, and Trouble. Snow accumulation for the night was 2-3 inches.

Tuesday 02/27/2024

The Day crew assumed control of plowing operations at 7:00 a.m. as temperatures remained at 5 degrees with a consistent 17 mph wind throughout the morning. Given the reduced amount of snow, the Day crew focused on clearing priority routes. Thanks to their diligent efforts and the absence of further snowfall, the road conditions improved to a satisfactory level.

Event 7 was closed at 11:30 a.m. on Tuesday, February 27, 2024.

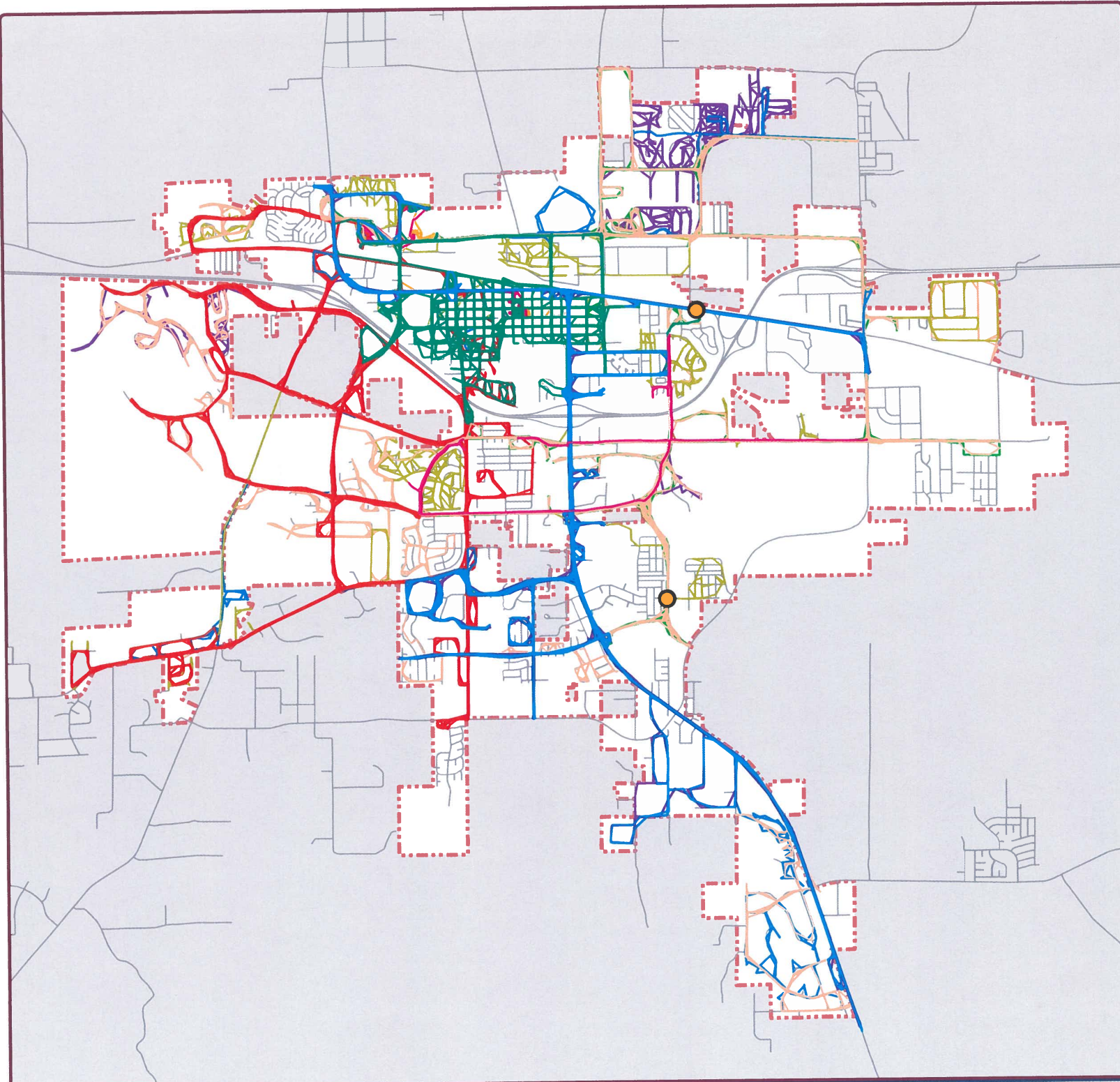

As we reflect on the complexities of economic development, let us remain optimistic, knowing that each step taken today contributes to a brighter and more prosperous future for generations to come.



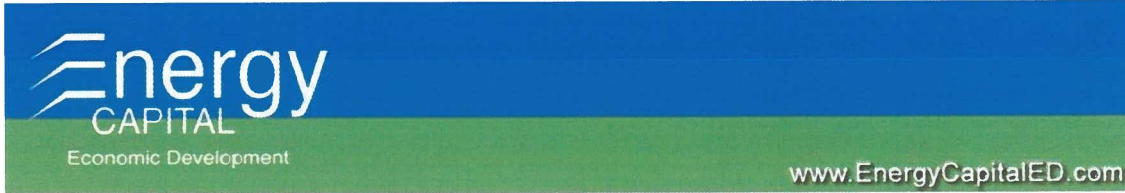

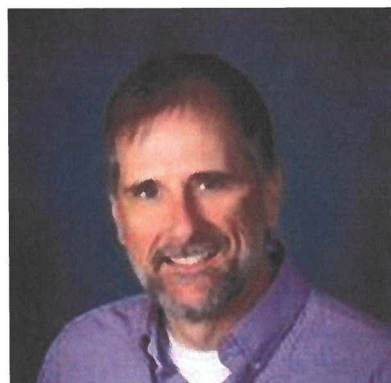

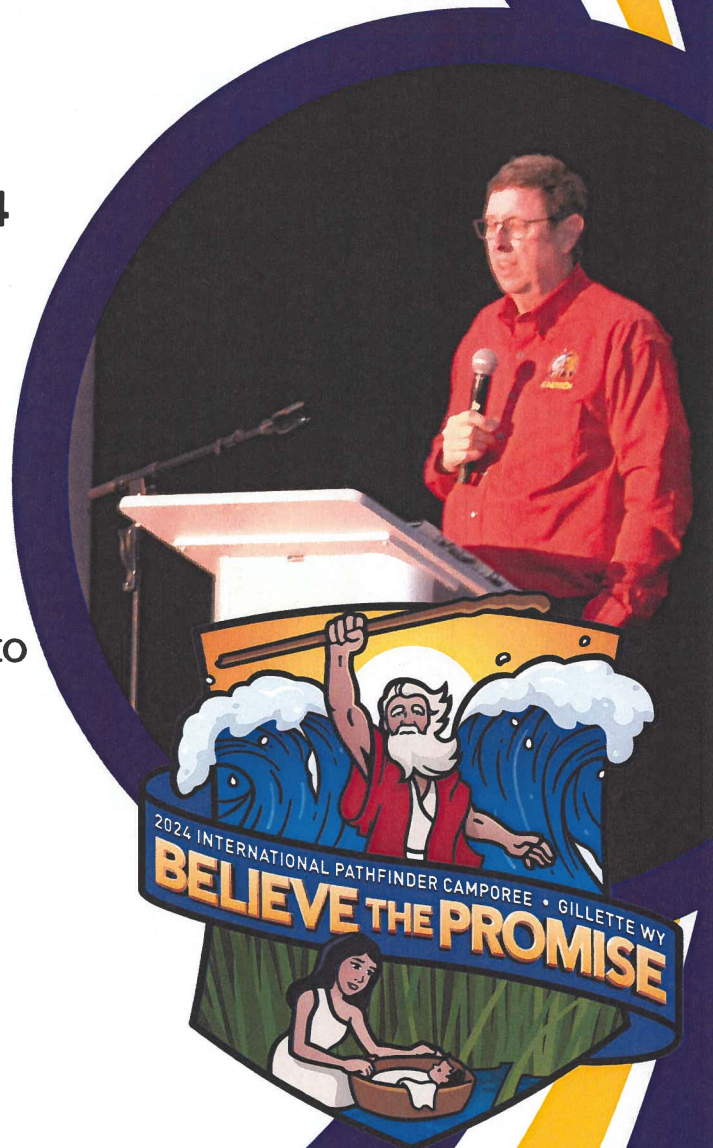
