## **2023 YEAR IN REVIEW**



As you take some time to look over our end-of-year wrap-up, it's important to remember that these numbers represent real people who you have helped through your support this past year. Without you, success for these families would have been impossible.

With that said, I would like to highlight some areas where your support has been invaluable in 2023. The number of nights of shelter we provided in our Emergency Shelter increased by 83%, increasing in both number of clients and length of stay. The reason for this enormous increase is due to the lack of housing in our community and more people struggling to keep up with the rising costs. The positive news is that your support has allowed us to shelter, feed, and clothe these families and individuals while providing housing-focused case management. The cost-of-living increases throughout the nation have also furthered the use of our Food Pantry and Soup Kitchen programs, where we are feeding more families and children.

This coming year, our focus will continue to be on how we can adapt and provide for our changing community. The Council has been serving Campbell County for over 55 years, and we will continue to keep all donations local to help families lift themselves out of poverty. With the support of our community and donors like you, we can make a difference for so many, regardless of who they are or the barriers they face. Together, we make our community stronger.



## Program Improvements

## **Food Pantry**

In 2022, the food pantry moved into the shop next door to our main office and we expanded into nine times more space, including more storage, a walk-in freezer, and more choices for clients. One of the goals in 2023 was to continue to reduce food waste, through tracking waste at food drives, creating boxes of feed for farm animals, and getting more close-to-expired food out quicker.

Another goal is to provide a better variety of food items for different cultures and food restrictions in our community.

## **Homeless Shelter**

Our shelter has made large improvements on staffing and training in order to better serve the growing number of clients that stay here. We've added additional staffing to help with case management, developed the new CCS Training Academy with required suicide prevention seminars, and better tuned in to what our clients need.

## **Other Improvements**

In 2023, we began offering assistance for the Affordable Connectivity Program which helps bring rural communities more accessibility to internet services and technology. This program will wrap up in February 2024.






