8.1.1 Financial Report

Director of Finance, Juli Pierce, presented the Financials. Cash balance as of 2/29/2024 was \$3,332.030.69 with total revenue at \$52,606.05 and Expenditures of \$856,533.72. WyoStar Vehicle Depreciation Account balance as of 2/29/2024 was \$4,189,979.62, Unencumbered Funds at \$3,126,871.22. Facilities Maintenance account ending balance on 1/31/2024 was \$211,870.92, Unencumbered Funds totaling \$131,870.92. Equipment Replacement balance as of 2/29/2024 \$738,634.53, with Unencumbered total of \$550,334.53.

FY 2023-2024 BUDGET VS ACTUAL

Pierce gave an update on budget vs. actual. YTD this time of year should be sitting at 66.7% used. She made note of a few accounts that will need budget funds transfer into: Professional Services, Employ Testing & Hiring Fees-Medical, Misc. Expenses (Insurance Reimbursements for Hail Damage), Capital Outlay-Equipment & Capital Outlay-Other.
