City Council has approved an agreement with Campbell County Parks and Recreation to again provide free open swim sessions at the Campbell County Recreation Center Pool. These free sessions are offered during the summer season while the City Pool is closed for construction.

Beginning on Tuesday, May 28, 2024, free open swim sessions will resume at the Campbell County Recreation Center Pool Monday through Friday from 1 p.m. to 4 p.m. and Saturday and Sunday from 1 p.m. to 4:30 p.m. Pool patrons will be asked to sign in at the front desk, but there will be no charge for attending these sessions. Other designated open swim sessions are available only to pass holders or paying customers.
