This Development Review Schedule applies to Development Plans, Plats (Administrative, Condominium, Sketch, Preliminary & Final), Major Site Plans, Vacate Requests and Zoning Requests (No Staff Review).

The Planning Division has a minimum review time of ten (10) business days following the uploading of completed plans and permits into Energov.

1. The Parks and Beautification Board reviews Development Plans and Preliminary Plats only.
2. The City Council reviews Final Plats (except Administrative and Sketch), Vacate and Zoning Requests.
3. Annexation requests can be submitted anytime. The review and meeting schedule will vary depending on the submittal date and required public notifications.
