Full depth removal of all pavement along Allen Avenue between Sutherland Drive and Lakeway Road including removal and replacement of majority of PCC curb and gutter, valley gutter, fillets, ADA ramps, driveways, and sidewalks to facilitate changing the grade of the existing road profile. PCC storm drain box culvert crossing Allen Avenue will be removed as well as removal of approximately 520 LF of PCC low flow drainage channel east of Allen Avenue to be replaced with 42" RCP storm drain main including inlets, structures, fittings, appurtenances, headwall and PCC low flow channel transition. Existing channel to be filled and resurfaced with PCC drain pan and surfacing. Remove existing storm drain system in Allen Avenue and install curb inlets and storm drain laterals. Remove and replace existing prefabricated fiberglass dewatering well and force main discharge pipe near Lakeway Road. Install approximately 410 LF of new 8" PVC sanitary sewer main including reconnecting 4" PVC services, manholes, fittings and appurtenances along new alignment while removing and or abandoning existing sanitary sewer main and manholes. Minor water fitting replacement along Allen Avenue between Sutherland Drive and Sutherland Lane Cove including 110 LF of 6" and 8" PVC water main, hydrants, valves, main lowering, fittings, and appurtenances.

Alternate work includes full pavement replacement of approximately 4000 SY as either 4" asphaltic concrete paving or 7" portland concrete cement paving with respective aggregate base course sections. Additional alternate work includes removal of approximately 375 LF of additional PCC low flow drainage channel west of Allen Avenue to be replaced with 42" RCP storm drain main including inlets, structures, fittings, appurtenances, and relocation of base bid headwall and PCC low flow channel transition. Existing channel to be filled and resurfaced with landscape surfacing.
